Explanatory notes:

Note A: UN Comtrade data in this table was calculated using the Norwegian Initiative on Small Arms Transfers' (NISAT) reliability index (see small Arms Survey, 2005, box 4.1, pp. 99–100; Marsh, 2005).

Note B: The cut-off date for inclusion of data from national arms export reports in this table is 16 January 2009.

Note C: Customs data and national arms export reports as well as the EU Report diverge for a number of reasons. Two important causes of discrepancies are: (a) unlike customs data, national arms export reports sometimes do not include exports of what is categorized as 'civilian' weapons; and (b) many countries use the Wassenaar Arrangement Munitions List (ML) in their arms export reports. The categories of the ML, with one exception (ML1), do not distinguish small arms and light weapons from other types of weapons. The Small arms Survey records the ML1 value in the table; hence many types of small arms and light weapons and all types of small arms ammunition are excluded (Small Arms Survey, 2005, pp. 101–02) i

Note D: Some top producers of small arms, e.g. China and the Russian Federation, publish only limited customs information on their small arms and light weapons exports. In order to properly reflect their presumed importance in the small arms trade, the Small Arms Survey goes beyond UN Comtrade data. China is still estimated to export USD 100 million worth of small arms and light weapons. For details, see Small Arms Survey (2004, Annexe 4.1). For the Russian Federation, figures were developed on the basis of field research (Pyadushkin, 2006).

Note E: In this table, transfer can also mean the movement of small arms for repair, and the devolution of parts and weapons to licensing companies (see Box 1.1 in ch. 1).

Note F: Top exporters (those with an annual export value equal to or greater than USD 100 million, according to UN Comtrade and estimates) are set in bold.

Note G: UN Comtrade figures exclude a variety of weapon types and ammunition, such as man-portable missiles, thus the actual figures for some countries are probably underestimates.

Country-specific notes:

- 1 Belgium no longer publishes a national arms export report (see Small Arms Survey, 2006, Table 3.1, pp. 68–69). Its arms exports are analysed by examining all three regional reports issued by Belgian regional authorities and the report by Belgian Parliament on activities of the Belgian military and police.
- 2 German arms export report as well as Germany’s reporting to the UN Register of Conventional Arms and its section in the consolidated EU Report covering 2006 exports only include information on authorizations, not on actual deliveries.
- 3 The Italian national export report covering 2006 exports only includes information on authorizations by military list, not on actual deliveries. The report also includes an annexe with information from the Customs Agency (Agenzia delle Dogane) on actual deliveries by company, product, and value (Italy, 2007). The report provides neither a total figure for small arms and light weapons exports nor a breakdown by recipient country.
- 4 Portugal’s arms export report covering 2006 does not distinguish small arms and light weapons from other military weapons.
- 5 Ukraine’s arms export report covering 2006 exports does not give the value of exports, but only the quantities.
- 6 The United Kingdom’s arms export report covering 2006 exports only includes information on licences granted, not on actual deliveries.
- 7 The US State Department report pursuant to section 655 on direct commercial sales covering 2006 exports only includes information on authorizations, not on actual deliveries. The report on foreign military sales, which is prepared by the US Department of Defense, does list actual deliveries.
